PRESIDENT'S MESSAGE



I am sure you are all knee deep in your budget planning. This year the governor has made our task more difficult by refusing to provide budget runs based on his executive budget proposal. From his State of the State address he has attacked public education at every turn. In the recent *OnBoard*, Tim Kremer's new game of suspense and intrigue *Cuomo-nopoly* definitely illustrated many of the dilemmas with which we are faced.

Clearly our push this year must be to make sure the Gap Elimination Adjustment (GEA) goes away and stays away. Senator Patrick Gallivan and Assemblywoman Carrie Woerner have co-sponsored a bill to do just that this year. Please be sure to thank them for their courage to push this issue. By the governor's own admission, he has single-handedly raised our State from the depths of despair and dysfunction to a place that now has a budget surplus.
