FROM YOUR AREA 2 DIRECTOR



I wish you all good fortune in the budget votes on May 19th. It has been a trying budget season with the governor withholding any district information until the "three men in the room" left the room. And then, to include policy changes within the budget adoption, I believe has created an unfortunate precedent that the governor will likely increase using in future years. On time budgets are appreciated only when they are

meaningful and done properly. I do appreciate the efforts of our legislators in lobbying for additional State Aid. However, as my superintendent often states, "It is not an increase in aid, it is *less of a <u>decrease</u>* because money is still being taken back via the GEA." We need to continue our lobbying efforts to eliminate the GEA and to have the Foundation Aid formula changed so that every district in the State is able to ensure that all children are provided a "sound, basic education". The Foundation Formula must be constructed in a way so that all children have opportunities to be prepared to prosper in the global society. All children "regardless of their zip code" must be college and career ready.

Speaking of "college and career ready", I also want us to maintain the focus on what the real issues are. I hear some people want to blame the Common Core Learning Standards (CCLS) for all the difficulties in our education system. It is not the CCLS; it is the way they are being tested and how the testing data is being used. The Learning Standards themselves are worthwhile; we should want to have our children better prepared for college and career. The fault is not the standards. The fault is with how the tests are developed and then how the results are used. Test "refusals" place our children in the middle of making adult statements. We should be lobbying Albany to not do away with the Standards but to change the tests. Assessments must be relevant, valid, and reliable. We must also keep the focus as to what "test scores" mean ... they are one piece of a series of multiple measures to guide our teachers' instruction. Test scores may indicate which students need additional supports to meet exit outcomes ... they always have. Good teachers have always used how students perform on tests to inform their instruction, to understand what needs to be retaught, and to revise curricula. We need to refocus the discussion on what the problem really is. It is not the learning standards; it is the manner in which the standards are being tested and then how the results of the testing are being used.

As I said at the outset, have a successful budget vote and election of new Board members. Thank you for all you do every day for our children.


